Where Your Money Goes

Funds will be disseminated with the board's approval and with the advisement and input from the Advisory Committee of the Oklahoma Highway Patrol

- **Emergency Financial Aid**
 - Assist with providing financial support for Troopers as a result of injury, incapacitation or death in the line of duty
 - Assist with gaps in retirement for those that do not meet or fall short of the OHP's catastrophic event requirements
- **Family and Mental Health Services**
 - Develop and support a wellness center with programming and services for Troopers and their families
 - Assist in providing programs and tools necessary to maintain a healthy lifestyle – physically and emotionally
- **Education, Training and Outreach**
 - Provide training and leadership development opportunities for Troopers and Supervisors
 - Provide funding to adequately assist recruitment efforts and public education, interaction and outreach

How your Money is Managed

The Foundation's funds will be managed by Foundation Management, Inc.

- **Financial**

- Create a specialized accounting plan and assist with a spending policy and budget
- Provides a projected minimum distribution calculation for each accounting statement to assist in budgeting future grants
- Reconcile monthly bank statements, investment statements and other pertinent financial records. FMI will prepare annual tax workbooks and accompanying documents to provide to appropriate firm
- FMI will develop and implement a grant-making plan, using traditional or web-based programs

- **Administrative Support**

- FMI will provide general office administrative and support services including government compliance, meeting planning, facilitating board retreats and any other administrative services

- **Compliance, Risk Management & Insurance**

- FMI will ensure clients are in full compliance with IRS rules and regulations
- FMI will assist the foundation in assessing risks and bringing insurance options to consider
